

FDA Warning Issued to Nursing Homes for Recalled Food Products Containing Peanuts

The FDA and Centers for Disease Control and Prevention (CDC) have received reports of deaths of elderly nursing home residents who had underlying health conditions and had consumed recalled food products containing peanuts contaminated by *Salmonella*.

The FDA is issuing a warning to nursing home and other long-term care facility administrators, owners, and food managers to ensure they are aware of the dangers of their residents eating recalled food products, and urging them to check their institutional supply of peanut butter and other products containing peanut ingredients for food items that may be affected by the recent voluntary recalls.

FDA offers a searchable database of recalled products and urges personnel at nursing homes and other long-term care facilities to continue to check it often, as more recalls are added, by visiting http://www.accessdata.fda.gov/scripts/peanutbutterrecall/index.cfm

Delegate's Update

The House of Delegates is preparing for its first ever virtual meeting. We have had meetings to bring us up to speed with the technical side of things. But real success will depend upon everyone making a real effort to participate by sending in their pictures and completing their own personal slide, as well as chatting with one another to get some experience with that type of communication. ADA has been very supportive in addressing the technical needs and the training required to make this work.

I can actually imagine a time when only the most important meetings will justify the expense associated with a face-to-face meeting. I think the technical aspects of doing live meetings will become easier to use. We will just get used to doing business that way. It seems to me this is something WDA should explore for board meetings and committee meetings, given the great distances we have to travel to meet face-to-face, not to mention the weather and nasty roads we often have to negotiate.

The things we will be dealing with at the Spring meeting include the following "Mega Issue" questions:


- What can RDs/DTRs do to prevent childhood obesity?
- Recommendations exist on how to combat childhood obesity. Despite knowing what needs to be done, why hasn't it been universally successful?
- How can RDs/DTRs best collaborate with policy makers, school personnel, health care providers, families and the community to effectively prevent childhood obesity?

By addressing this issue the House hopes to gain an understanding the current trends and cultural values related to the prevalence of childhood obesity in the US and to become aware of the current programs and resources addressing the prevention of childhood obesity.

Delegate's Update Continued

ADA understands that any successful intervention will require a combination of family-based and school-based multi-component programs that include the promotion of physical activity, parent training/modeling, behavioral counseling and nutrition education. ADA wants to help position the RD to be a key player in any programs that are established to address this issue. It seems to me this is a topic that has broad grassroots support among our members.

For this report, I have included a copy of the NHANES data that shows the trends in childhood obesity in the United States from 1971 through 2006.
